You are accordingly required to follow the schedule and conditions below;

April 2018	■ Application procedure for your university (with JICE support).
May - July	Pre-Departure English and Mathematic Training (To be confirmed)
June to August	■ Assignments or pre-departure training by the universities. ※ This depends on your university.
June - July	■ Status of JDS Fellow will be entitled (see important notes 1) ■ This status is assured after an acceptance letter from your university is issued. ■ Some internal procedures (questionnaires, personal interview, etc.) ■ Pre-departure orientation (JICA / JICE) 4-5 days JDS rules, VISA, scholarship, Insurance, Departure & Arrival information in Japan, JICE support system in Japan, Advice from senior fellows, etc.
August	■ Send-off reception (at a hotel in Dili) ■ Departure for Japan

[Important Notes]

1. "Successful candidate" means those who are qualified to study in Master courses of Japanese universities by JDS selection. However, this status itself does not guarantee a status of "JDS fellow" to go to Japan and to receive scholarship. The status of the "JDS fellow" will be given when their universities officially issue a letter of acceptance through the application procedure taken after the JDS selection (In general, the acceptance letter is issued by each university in May or June of the year).
2. JICE JDS Office will be a contact point until you go to Japan. Therefore, please DO NOT directly



contact your university or academic advisors not to make them confused. They will contact you when they need to do so (Please check your email regularly).

3. In April after your successful result is announced, you have to take the application procedure for your University in which your acceptance will be officially determined by your applied university. If your acceptance were declined by the university, your scholarship as well as your status of successful candidate could be forfeit.
4. Please wait to take a long-term leave of absence from your workplace until the university officially accepts your admission.
5. You must join all the programs above giving priority on them on the ground of the "Permission Letter" that your workplace signed and you submitted before joining the final selection.
